Eligibility - The Match is open to all dogs fifteen (15) months of age or older that are registered with the American Kennel Club or that have AKC Limited Registration, Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP) or an AKC Canine Partners listing number.

Classes Offered - The "B" Match will offer a "Standard" course and handlers will have the opportunity to run Novice, Open and Excellent course at both Regular and Preferred heights. The MATCH will start at approximately 4:00 p.m. (about 30 minutes after the end of that day's trial)

Entries - Exhibitors must complete an entry form for each dog being entered. Completed forms can be mailed to Val Spadaccini, 535 Pond Brook Rd., Hinesburg VT 05461. Entries open March 19 and close April 15 or when limit of 50 runs are received. Multiple entries for the same dog will be allowed once all dogs have completed their first run, maximum of two runs per dog.

Height Divisions - All Regular and Preferred height divisions will be available and dogs should be entered at their appropriate heights. Dogs that have not previously been measured at an AKC trial will need to be measured on the day of the Match. Measuring for these dogs will begin available during the day.

Rules - A "B" Match is similar in many ways to a sanctioned Agility Trial. It is an excellent opportunity for handlers to experience the environment and rules of an Agility Trial in a slightly less formal atmosphere. All of the normal rules relating to obstacle performance, standard course times, entering and exiting the ring, etc apply. At "B" Matches, dogs in the ring may receive verbal corrections, harsh corrections are not allowed. Toys are allowed in the ring but not food. Exhibitors must follow the judge's verbal instructions.
